I ACCEPT ANY AND ALL RISKS TO MYSELF AND MY CHILD OF INJURY OR DEATH, AND PROP DAMAGE ARISING FROM PARTICIPATION IN THE PROGRAM AND THE USE OF THE FACILITIES AND PROP OF THE CLUB, WHETHER OR NOT CAUSED BY THE NEGLIGENCE OR OTHER ACTION, EXCEPT INTENTIVACTS, OF ANY OF THE RELEASEES.
